SUMMARY OF THE COURSE

In addition to learning some basic skills and concepts in visual arts education, students undertaking this course will think deeply about some of the most critical issues facing visual arts educators. The course will focus on the teaching of Artmaking in Stage 6 and students will be introduced to contemporary research into the teaching of art. Content knowledge will be integrated in pedagogy and linked to professional issues unique to visual arts educators. This course is designed with a view to students eventually becoming excellent teachers who are able to continue to improve the quality of visual arts education in Australia.

THE MAIN WAYS IN WHICH THE COURSE HAS CHANGED AS A RESULT OF STUDENT FEEDBACK

- The hurdle requirement is now held as a component of module 7, rather than earlier in the course. This change allows students more time to complete and submit the online assessment course and common e-portfolio. NB: The same portfolio covers both methods for which the student is enrolled.
- The focus of the course and activities prescribed have been modified to reflect syllabus content
- Assessments were modified to reflect feedback and reflect syllabus content

4. RATIONALE FOR THE INCLUSION OF CONTENT AND TEACHING APPROACH

This course will provide students with the capacity to extend their knowledge of curriculum and pedagogy, to operate effectively at the highest levels of schooling, and also to develop and refine their philosophical approach to education such that they can participate actively in professional organisations and advocate for an effective visual arts education.

5. TEACHING STRATEGIES

- Explicit teaching, including lectures, to demonstrate an understanding of students' different approaches to learning and the use of a range of teaching strategies to foster interest and support learning.
- Small group cooperative learning to understand the importance of teamwork in an educational context and to demonstrate the use of group structures as appropriate to address teaching and learning goals.
- Extensive opportunities for whole group and small group dialogue and discussion, allowing students
 the opportunity to demonstrate their capacity to communicate and liaise with the diverse members
 of an education community, and to demonstrate their knowledge and understanding of method
 content.
- Online learning from readings on the Moodle website.
- · Peer teaching in a simulated classroom setting.
- Structured occasions for reflection on learning to allow students to reflect critically on and improve teaching practice.

These activities will occur in a classroom climate that is supportive and inclusive of all learners.

Assessment Details

Assessment 1: Assessing understandings of Practice – Assessment Task Design and Evaluation

Design a formative assessment task that requires students to demonstrate their understanding of practice in the development of their body of work. Design a marking criteria that reflects the parameters of the task. Provide a rationale (800-1000 words) which explains and justifies your choices and addresses how the task provides the teacher with access to students' understanding of practice.

Assessment 2: Essay - Assessment and pedagogical practice in the development of the body of work

Consider how strategies in assessment and pedagogy can be used by teachers to support students to develop their role as an artist in the development of the body of work. Include your findings regarding the implications of your research for teaching. Ensure that you include appropriate references. Your response should be 3000 words.
