### Progression Plan for 2020 Commencing Students

Terminology	Definition
<b>Program compulsory core courses &amp; flexible core courses</b>	54UOC of compulsory first and second year Commerce and Economics courses which students must complete.  Choose 18UOC (3 courses) flexible core courses from list.
<b>Commerce Major</b>	A sequence of approved courses (48UOC) in an approved discipline stream offered by the UNSW Business School (See Appendix A.), containing at least 18UOC at level 3. (Note that the 48 UOC includes the first disciplinary course(s) in the Core (Compulsory or Flexible). This means that, for the majority of majors, students will complete 42UOC in specified disciplinary courses outside the core.)
<b>Economics Major</b>	Students must complete at least one major in Economics, Econometrics or Financial Economics consisting of 60UOC. The 60UOC includes 24UOC from the compulsory first year core courses. (ECON1401 do not count towards any major.) Students must complete at least three (3) level 3 courses (numbered 3XXX). If a student chooses to complete a second Economics major, they must choose another 6 courses (36 UOC) from the second major that do not overlap with the first major.
<b>Economics Electives</b>	Account for 12UOC (2 courses) from the School of Economics to ensure a student completes a minimum of 78UOC of Economics courses within the School of Economics.
<b>UNSW Business School Elective</b>	UOC remaining after completion of the Compulsory core, Flexible core and Major requirements for this program should be taken from within the UNSW Business School to ensure a minimum of 84 UOC of Economics courses are completed for the Economics component and a minimum of 96 UOC of UNSW Business School courses are required for the Commerce component. GEN courses cannot count as Business School electives.
<b>General Education</b>	Account for 12UOC (2 courses) and are to be taken outside the UNSW Business School. Please note that students enrolled in programs within the UNSW Business School cannot take General Education courses offered by the UNSW Business School (i.e. GENC code). These restrictions also apply to the following courses: GENL2021 An Introduction to the Australian Legal System, GENL2032 Cyberspace Law 2.0.  General Education courses do not contribute towards the 72UOC Level one limit.
